2023-24 Tuition Assistance Application**

Need-based tuition assistance will be offered in various amounts equitably based on demonstrated need to parents/students who apply. Although tuition deposits are not due August 12, 2023 for parents/students who apply for need-based assistance, equitable tuition deposits will still be required and due after award notices are sent.

Parents who would experience hardship by this requirement may request payment plans on a case-by-case basis with the Manager of Music Education. Participation in the JSYO is always based upon merit and never on a student's ability to pay tuition.

1. A complete Tuition Assistance Application Form
2. The family's most recent Federal Tax Form 1040
